- 1 The above financial result of the Company for the quarter and nine months ended 31st December, 2016 were reviewed by the Audit Committee, approved by the Board of Directors at its meeting held on 13th February, 2017 and have been subjected to a "Limited Review" by the Statutory Auditors.
- 2 Provision for income tax and deferred tax, if any, will be made at the year end.
- 3 There are no other reportable segments as per AS 17 (Segment Reporting), except Finance and investment, as such reporting is done on that basis.
- 4 The Board of Directors, at its meeting held on 9th April, 2016, approved the Scheme of Amalgamation of Aroni Commercial Ltd with Saraswati Commercial (India) Ltd. The company filed the Scheme amalgamation with the Stock Exchange - BSE Ltd. BSE Ltd has issued a No Observation Certificate to the company with respect to the same. The Company has filed an application on 12th August, 2016 to Hon'ble Bombay High Court. As per the directions of the Hon'ble Bombay High Court of Bombay in their order dated on 29th September, 2016 the Court convened Meeting of its shareholders of the company was held on 10th November, 2016 and the shareholders have approved the scheme of Amalgamation. The Company had filed a petition with Hon'ble Bombay High Court on 2nd December, 2016. However, as per the notification issued by the Ministry of Corporate affairs dated 15th December, 2016 all the rights of Hon'ble High Court have been transferred to The National Company Law Tribunal (NCLT). The NCLT has passed an order on 17th January 2017 for admitting the Petition and fixed for hearing & final disposal on 6th March 2017 subject to the conditions as mentioned in the order.
